Gullion Family Timeline

- 1764—Robert testifies he was born near Fort Frederick, Potomac River 4th, 1764.
- 1765—Henry marries Margaret Stinson in PA.
- 1772—Robert O'Gullion, Virginia Deed transferred to PA, Tyrone Twp, Westmoreland Co PA (present day Fayette Co), from Md/VA.
- 1773—Patrick O'Gullion, tax list Hempfield Twp. Westmoreland Co, PA (Hannastown)
 - --Robert O'Gullion, Tyrone Twp., Westmoreland Co, PA
 - --Edmond P. Gullion, Hempfield Twp. Westmoreland Co PA
- 1775—John O'Gullion enlisted under Capt Joseph Irwin at Hannastown, PA, also under Luet. Joseph Brownlee, James Carnahand, David Loan, rifle Co attached to the 2nd PA Reg commanded by Col. Daniel Broadhead
 - --The King vs. Patrick O'Gullion, Westmoreland Co, PA, "forcible entry & Detainer"
- 1776—Testimony (given 1819 by James White) that John lived near Robert Gullion in Westmoreland Co, PA.
 - --Robert testified he lived in Westmoreland Co, PA on Big Seventy Creek (Sweetly, or Sewickley Creek), then in KY 3-4 years, then in IN for 33 years.
 - --John testified he marched to: Marcus Hook on Delaware River in Col. Broadhead's Reg together with Col. Miles & Col. Piper's Reg. along w/ Capt. Irwin; then to Lewistown near cape of Delaware; to Philadelphia marching; by water to New Bruneswick, NJ; to Elizabeth, the New York to Long Island where there was a severe battle, in which brother Jeremiah was wounded; then marched to King's Bridge, and wounded severely in a skirmish in NJ. He was with (or was) First Sergeant of Capt Irwin's Co, Wm. McCord; others of his company: Jeremiah Gullion (brother), Wm. Dawagh, Wm Nelson, Andrew Bryson, Wm Guthrie, Daniel Brumfield (killed at Long Island) he was considered to have served on land and in naval service.
- 1777—John was known by Lieutenant James Erwin to have "come home" in Fall
 - --known by Nancy Roddey to have enlisted in her father's regiment (Capt Joseph Erwin), marched with him April '76, home late '77
- 1777—John discharge from Valley Forge, severely wounded.
- 1778—testimony from Henry Willyard states John served 6mo in Capt Matthew Jack's Co of 8th Reg PA line, Col. Byard, and 6mo for Capt John Shearer 8th PA line under Col. Davis.
 - --Robert testified that John Gullion served under Capt. James Patton of Col. Hardin in tour of Illinois State (likely under Gen. George Rogers Clark? In 1778, summer).
- 1780—Jeremiah stated he moved to Lexington with his father, near the mouth of Eagle Creek,

- Carroll County, KY. (moving to IN about 1783-84)
- --Summer 1780 Jeremiah states he served under Gen George Rogers Clark against Indians at Chilcothe & Pickway, known to have been an expert Indian fighter, expert spy.
- 1780-81—Robert Gullion testified he served as Militiaman, as a ranger of Westmoreland Co, PA. Stationed at block house of Turtle Creek, PA about 12 miles from Braddock's Field.
 - ---John & Robert O'Gullion listed in Washington CO, PA (created from Westmoreland Co), Rangers, Privates.
 - ---John listed as a Ranger in Jeremiah Lochry' Hannastown 1781.
- 1782—Thomas McCreary testified John O'Gullion served w/ him at Crawford's defeat at Sandusky (Ohio) under Captain Andrew Hood of Col Crawford.
 - --Robert served under Capt Andrew Hood, Col. Wm. Crawford, marching from Mingo bottom of Ohio River against the Indian towns of Sandusky, defeated by the Indians June 4th, "Nicholson, Slover, & James were our spies or pilots."
 - --July 13th, Jeremiah was at the battle of Hannastown, PA.
 - --August 19th, Jeremiah was at the battle of Blue Licks, KY.
- 1783-84—Jeremiah states he moved to Indiana.
 - --Patrick still listed 1783 to 1788 on census in Westmoreland Co, PA.
- 1778-83—John & Robert listed as Rangers of Westmoreland Co, PA in John Cisna's Co.
- 1788—Forks of Elkhorn Church—Jeremiah O'Gullion, states Jeremiah and Jack (John) said to be first settlers of Frankfort, KY; Jeremiah built the first house where the Methodist Church now stands (not sure when that was stated).
- 1790—Benjamin Drake testifies that he served with John O'Gullion under Col. McMillin (Major James McMillin who led 150 Kentucky militiamen) at their defeat on the St. Joseph & St. Mary's under General Harmar, known as Harmar's Defeat in October (in Northwest Territory against the Indians, fought w/ 60 US Army men and 340 Militiamen from PA and KY)
- 1792—Jeremiah purchased two lots of four acres from James Wilkinson on Washington St in Frankfurt, KY for five shillings, currency of Virginia.
- 1793—Henry (son of Patrick, father of Edmond, grandfather of John, Rbt, Jeremiah) enlisted at Fort Washington under Major Gen. Charles Scott, Lt Col. Wm Russel's Regiment, Capt. George Frazier's Company, as a Sergeant. (Fellow sergeants were: James Allen, Henry Curtner, Samuel Lowry, Wm. McClellan, Anthony Samuel). described as a list of mounted Kentucky Volunteers. Fort Washington is present day Cincinnati, north side of the Ohio River, just southwest of Dayton. Sept-November.

- --John (grandson of Henry) Oct-Nov, Major Gen Charles Scott, Lt. Col. Horatio Hall's Regiment, Capt Henry Barlett's Company, as a private; "left sick at Fort Hamilton, present at muster" mounted volunteer.
- 1796—1803 indenture between Edmond and Patrick and Henry states the deed to Lexington property was initially dated 1796. It also verifies that Edmond is son of Henry.
- 1802—Gallatin Co, KY, on lands of Jeremiah Gullion, tobacco, hemp, flour, at the mouth of Eagle Creek on Kentucky River.
- 1805—Patrick (grt grandfather of John) dies in Lexington, October.
- 1811—Jeremiah testified he recalled an earthquake.
- 1816—Jeremiah's will in Gallatin Co, KY.
- 1832—John O. Gullion living in Dearborn Co, IN.
